Data subjects

This information note is addressed to all those who use the forms on the site (clients, prospective clients, candidates). Data will be processed in different ways depending on the purpose of the applicant, as specified below.

Purpose

The personal data collected from the data subject, the user of the website, are the subject of the processing and are processed and used directly for the following purposes:
